## Rules to be followed by all applicants:

- 1. Applicant, if individual, should have completed 18 years of age.
- 2. Individuals / Institutions can apply for Awards under the category "Environmental Awareness and Education"

- 3. Applicant, if individual, should enclose such of those details of the work carried out and its usefulness, which were not considered for any awards by the Government of Tamil Nadu.
- 4. Individuals / Institutions applying for the Award under "Environment Protection and Management" category should furnish the details of field work undertaken during the period 01.01.2022 to 31.12.2022 mentioned in the announcement, related pamphlets, newspaper clippings, project report, the usefulness of the field work undertaken, number of beneficiaries / participants.
- 5. Such field work shall be inspected by officials of the concerned department / members of the selection committee.
- 6. Individual / Institution shall apply for only one category for awards under "Environment Protection and Management"
- 7. For the above categories, the eligible candidates / organizations from Tamil Nadu alone should apply.
- 8. Applicants should be made for each category in the specific for that category.
- 9. The individuals / organizations who have already received the awards from the Department of Environment are not eligible to apply.

## **Specific rules for a best research paper:**

- 1. To encourage research in the field of Environment, best research paper published individually / jointly during January 2022 to December 2022 are proposed to be awarded with a cash prize and a citation.
- 2. Research papers published in reputed scientific journals in English / Tamil alone will a entertained.
- 3. If the research paper is in English, a Tamil translation should be furnished.
- 4. Proof for publication in the scientific journal should be furnished.
- 5. Should be published during the period mentioned in this announcement.
- 6. If the research paper is in the form of a Book, the entire book should be enclosed.
- 7. If the research paper / book has been published jointly by more than one person, then the primary individual alone is eligible to apply.
- 8. Four copies of the research paper should be sent.

9. Those who have already received the awards from the Department of Environment and Climate Change are not eligible to apply.

## **Follow the instructions to apply:**

- 1. The application should enclose any proof of activities undertaken in the form of pamphlets / processions or any other documents with relevant photographs.
- 2. Application form and their attachments should be firmly stitched with thread and not stapled.
- 3. Mentioned the number of documents enclosed along with the application.
